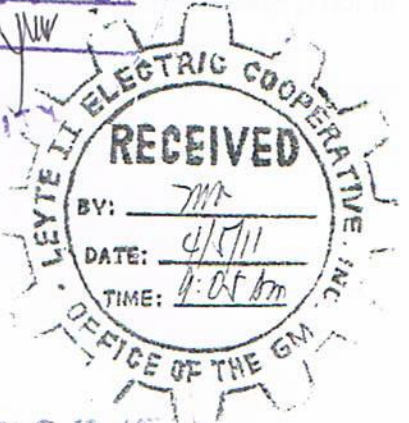
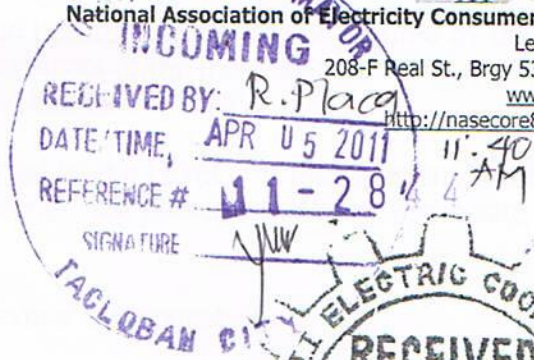

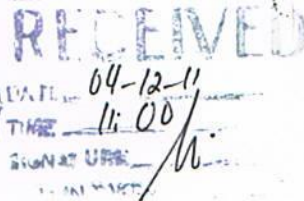

Greetings!

This refers to the sub-item "Account of NEA/former personnel" under the item "RECEIVABLE MRR to PSALM MISCELLANEOUS under item 9, "Other Accounts Receivable" of the 2010 Annual Report of the Leyte II Electric Cooperative, Inc. (LEYECO II) in the amount of Php 215,276.

Since this is under the item labeled as Other Accounts Receivable, we take this to mean as loans or advances to NEA personnel and former NEA personnel.

In this regard, May we know the following?

1. The nature of these accounts receivable and how were these incurred by NEA personnel and former NEA personnel;
2. The list of names of the NEA and former NEA personnel who were beneficiaries of these facility and the amount and date these loans were availed of by the individual beneficiary and the outstanding individual balances from 2001-2010;
3. The authority creating the budget and the approval of such budget for the said facility;
4. If there was, the confirmation by NEA of said LEYECO II resolution;

These accounts receivables appear in the previous annual reports of LEYECO II which means that this facility has been in existence for some time now.



We are so much interested to have this information because we want to be assured by the LEYECO II management that all its revenues from the rate payments of the member-consumers are applied and used only in the actual cost of service of an electric distribution utility.

Lastly, may we know the efforts, if there are, exerted by the LEYECO II management in collecting these advances/loans to the NEA personnel and former NEA personnel? We will appreciate proof of such efforts.
