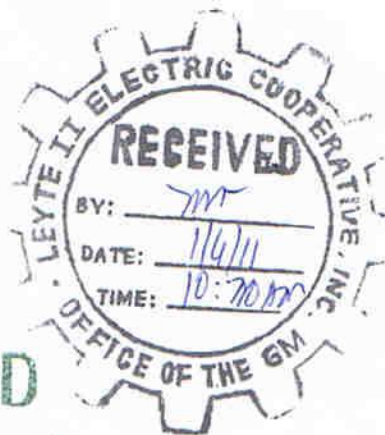

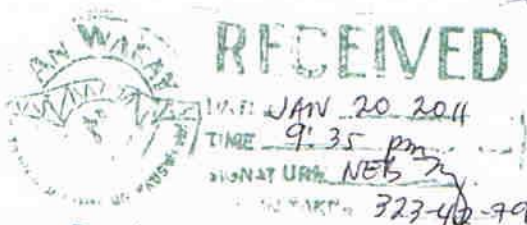

Dear GM Conde,

Greetings!



This refers to the Energy Regulatory Commission (ERC) Order under ERC Case No. 2009-111RC which granted LEYECO II a provisional authority dated January 11, 2010 to implement its proposed Revised Rate Schedule.

The Order explains that the new regulatory framework as embodied in the newly ERC-adopted Rules for Setting Electric Cooperative –Wheeling Rates (RSEC-WR) seeks to develop a regulatory regime that encourages efficiency in the operations of the ECs and provides incentives for their good performance. And under the said Order, LEYECO II was granted a new monthly charge, on a per kilowatt-hour basis, called "Member's Contribution for Capital Expenditures (MCC)" in the amount of P0.1518/kWh and this was implemented in January 2010.

In this regard, may we be informed of LEYECO II's monthly collections from this new monthly charge from January to December 2010 on a per customer category?


May we also be informed of the monthly disbursement of this fund and its specific application supported by copy of the Board Resolution, vouchers, and official receipts from suppliers?

We will take your immediate and favorable response to mean as the product of the new regulatory framework which granted LEYECO II a rate increase in order to promote efficiency that will redound to benefit its member-owners.



We look forward to a new year that will also encourage transparency and accountability in the operations of LEYECO II.
