This refers to the rate adjustment in monthly generation charge imposed on us which the table below will show:

With these monthly adjustments, could you please give us the components of the generation charge and how is this computed?

And in order for us to better understand these monthly adjustments, may we be furnished copy of the Supplier-issued official receipt (O.R.) and the total monthly collection of LEYECO II from the generation charge from September 2010 to June 2011?

In the interest of transparency and good governance which we know LEYECO II is mandated to practice, may we look forward to your immediate and favorable response.
