



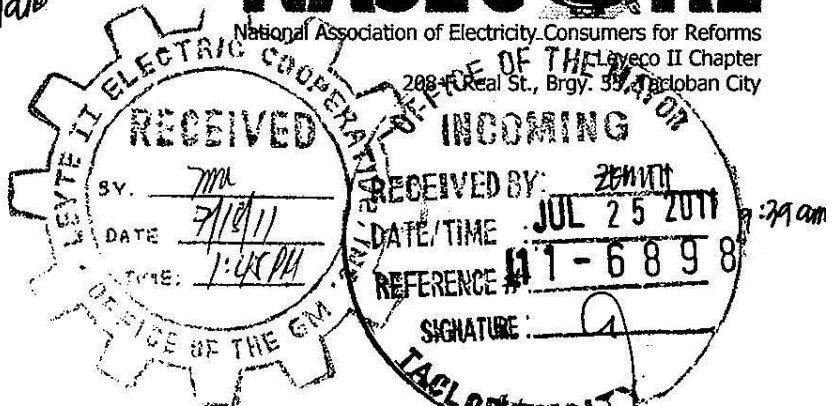

Dear Atty. Conde,

This is to acknowledge your letter dated 12 June 2011 which we received at 6:45pm last night furnishing us a copy of the Energy Regulatory Commission's (ERC) Order dated June 29, 2011 and the accompanying NOTICE OF PUBLIC HEARING, also dated June 29, 2011, in connection with the **APPLICATION FOR THE APPROVAL OF THE POWER SUPPLY CONTRACT (PSC) AND COMMISSIONING POWER SALES CONTRACT (CPSC) BETWEEN THE LEYTE II ELECTRIC COOPERATIVE, INC.(LEYECO II) AND KEPCO-SPC POWER CORPORATION (ERC CASE NO. 2011-080RC)** and inviting us to attend the said public hearing so we can have the opportunity to raise our issues and concerns relative to the two (2) PSCs. Please be advised though that the application does not include copy of the power supply contracts.

First, allow us to express our extreme surprise because while we welcome such gesture as something positive on LEYECO II's part, what you provided us was something we didn't ask for but can be easily sourced from the website of the Energy Regulatory Commission (ERC).

This only reminds us of the data and documents we have requested through the numerous letters we sent you that have remained unanswered. Your gesture would have been appreciated more had you granted our various requests which were meant simply to establish accountability and transparency that the Electric Power Industry Power Reform Act (EPIRA) calls for.

Your continued refusal to grant our request have made us feel betrayed and we really hope you start to act in accordance with the award you have received from NEA as "THE BEST GENERAL MANAGER" and the award the coop received as "THE BEST ELECTRIC COOPERATIVE, INC."

We take this opportunity then to reiterate our request which we hope you will now favorably grant.
