Dear GM Conde,

This refers to the power demand and supply need of Leyeco II which comes from the new owners of the geothermal plants in Tongonan, Leyte. We understand that the Visayas electric cooperatives (EC's) that compose the Association of Visayas Electric Cooperatives (AVECO) are wary of the looming power rate increase as set by the new owner/operator of these geothermal plants

In our desire to better appreciate the power situation in Region VIII, may we be furnished the following:

1. actual kilowatt-hour (kWh) purchases of Leyeco II from January 2010 to November 2010;
2. generation charge per kWh from January to November 2010;
3. current monthly power supply demand of Leyeco II (off-peak and peak combined);
4. rate proposed by the new owner of the geothermal plants;
5. level of power supply that the new owners will supply to Leyeco II.

These data will allow us to raise the concerns of the electricity consumers of Region VIII in the ongoing deliberations on the confirmation of the appointment of DOE Secretary Jose Rene D. Almendras at the Senate of the Philippines.

The hearing yesterday, December 14, 2010 was attended by NASECORE President, Mr. Pete L. Ilagan and according to him the hearing was suspended and will resume next January 2011. The data we are requesting will allow NASECORE President Pete Ilagan to raise the concerns of Region VIII EC's.

We look forward to your immediate and favorable response.
