Dear ERC Commissioners,

Greetings!

This refers to the application of the Leyte III Electric Cooperative, Inc. (LEYECO III) for the approval of a reduction in rates and loan condonation in compliance with Section 60 of R.A. 9136 and Executive Order No. 119, with prayer for provisional authority under ERC Case No. 2003-346 which was filed on 20 June 2003 with the Commission.

Section 60 of the EPIRA effectively condoned all the financial obligations of the electric cooperatives (LEYECO III included) with NEA and other government agencies.

On 05 August 2003, this Honorable Commission issued an Order granting LEYECO III a provisional authority for a rate reduction to reflect the amount of loan (financial obligation) condoned in the amount of **P25,331,927.77** or equivalent to P0.3258/kWh for all classes of customers.

The Commission issued its final Decision on 13 September 2004 approving the final rate reduction for each class of customers, as follows:

May we also be updated as to when was this implemented, how much of the **P25,331,927.77** loan condoned has been enjoyed by LEYECO III customers and its remaining balance to date?
