

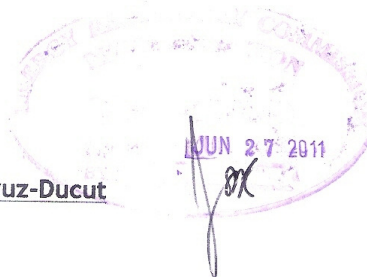

Dear ERC Commissioners:

Greetings!

This pertains to our study of Tarlac I Electric Cooperative, Inc (TARELCO I) financial statements showing an over collection of P249,687,723.00 from 2004 to 2008.

Our finding is based on this Honorable Commission's *Unbundling Decision* dated 25 June 2003 under ERC Case No. 2001-984 granting TARELCO I's annual revenue requirement of P130,062,076.00 (net of purchased power cost).

To determine if TARELCO I was getting its ERC-approved annual revenue requirement, NASECORE studied TARELCO I's 2005-2008 annual reports and compared its ERC-approved annual revenue requirements against its actual annual revenues as shown in the table below:

The table above clearly shows that TARELCO I realized an accumulated over-collection in the amount of P249,687,723.00 (net of purchased power cost) from 2004-2008. We still need to look into the 2009 and 2010 annual reports of TARELCO I to find out if there are also over collections in the said years.

We find these over-collections alarming because we take this as an abuse of market power when TARELCO I decided to deliberately keep to itself these over-collections instead of disclosing these by way of a petition to reduce its current rates but maintaining its approved annual revenues, especially that TARELCO I is a *non-stock, non-profit organization*.

It is a common industry knowledge that this increase in its annual revenues is attributable to the increase in its annual sales in kilowatt-hours and kilowatt from its captive customers owing to the increasing consumption of its customers and the reduction in its system loss. (emphasis supplied)

We also find this alarming because these TARELCO I over-collections show that the Honorable Commission blatantly failed to closely monitor and review the operations of TARELCO I to determine whether the annual revenue it granted TARELCO I is what is actually being collected only from the consumers based on its approved annual cost of service including its system loss percentage which should be reflected if the utility is operating efficiently or not.

Had ERC done its primary duty of reviewing the annual revenues it granted TARELCO I, it would have easily discovered these over-collections which NASECORE, on its own initiative, have discovered. It appears that ERC needs some reminding on its legal mandate of ensuring adequate promotion of consumer interests which basically revolves on determining just and reasonable rates.


Further, this ERC failure lamentably renders its approved annual revenues for TARELCO I (the result of its exhaustive study to ensure the viable operations of the electric utility) inutile as it failed to use these to serve as its way of ensuring that the TARELCO I rates it granted are just and reasonable.

In this regard, we urge ERC to immediately conduct a regulatory audit of TARELCO I and reduce its rates so as to stop this over-collection and to immediately direct a refund of this over-collection.

We fervently hope ERC will swiftly act on this request based on its mandate to protect consumers from unjust and unreasonable rates.
