Greetings!

This refers to your letter/reply dated 25 January 2011 to our letter dated 14 January 2011 requesting for NEA's Order confirming the appointment of Atty. Emmanuel Sano as the General Manager of Don Orestes electric Cooperative, Inc. (DORELCO) and Atty. Jerry Gwen Conde as concurrent General Manager of Leyte III Electric Cooperative, Inc. (LEYECO III) and for the corresponding Resolutions of the NEA Board of Administrators.

Your reply of 25 January 2011, however, only have as attachment your letter dated 30 October 2007 addressed to the Board of Directors of DORELCO confirming the DORELCO Board Resolution No. 052-06 "A Resolution Favorably Recommending to NEA for the Conformation of Atty. Emmanuel P. Sano as regular General Manager of DORELCO" effective 01 October 2007 and your letter dated 27 January 2010 addressed Atty. Jerry Gwen Conde informing him also of NEA's approval of the LEYECO III Board Resolution requesting the NEA Administrator to designate Atty. Conde as LEYECO III concurrent GM of LYECO III for one year effective 01 February 2010 meanwhile that applicant for LEYECO III is under process.

However, it failed to furnish us the NEA Board Resolution approving/confirming said appointments which we requested in our letter of 14 January 2011. While the NEA Administrator is authorized by law to designate an acting general manager, this is subject to the confirmation by the Board of Administrators and a copy of this confirmation is what we are requesting.

Further, the appointment of Atty. Jerry Gwen Conde as concurrent general manager of LEYECO II has already expired last 30 January 2011 if your letter to Atty. Jerry Gwen Conde is to be followed.

May we then reiterate our request for the NEA Board Resolutions on the appointments of Atty. Emmanuel P. Sano and Atty. Jerry Gwen Conde and the NEA set salary of these to (2) appointees? May we also be furnished copy of the NEA Board Resolution extending the appointment of Atty. Jerry Gwen Conde as concurrent general manager of LEYECO III?

In the spirit of transparency and accountability, we look forward to your immediate and favorable response.


