This refers to the Toyota Fortuner SUV which reportedly was purchased by Atty. Conde, LEYECO II's general manager, from a loan with the cooperative without any interest.

Report have also reached us that recently, Atty. Conde, purchased a set of brand new tires for this vehicle worth P100,000.00 and charged it to LEYECO II as part of the maintenance expense.

If these reports are true, this will bring disgrace to our Coop affecting even those who nothing to do in the said possible anomalous transaction.

In order to find out the truth, may we seek your personal intervention by furnishing us copy of the Board Resolution authorizing the car/vehicle loan without interest for the purchase of a brand new Toyota Fortuner and copy of all of Atty. Conde's amortization payments for this specific loan?

Further, may we also be furnished copy of the voucher/invoice for the payment of the one set of tires worth P100,000.00 for this said Toyota Fortuner? And may we know if this purchase was authorized by the LEYECO II Board? And if not, may we know by what authority was this purchase approved?

We understand this may be difficult on your part but as the president of LEYECO II, it is your avowed mandate to protect the cooperative from any possible anomalous transactions or you may be perceived as part of it if you refuse to provide us the aid documents.

We look forward to you personal support as the Coop president in bringing out the truth. Should you fail to respond honestly and truthfully, we shall course our request to the Energy Regulatory Commission (ERC) and the National Electrification Administration (NEA)?

And should our inquiry proved to the veracity of the reports we received, we will take the necessary legal action to bring the culprits to the proper venue.
