This refers to my letter of Feb 26, 2010 which Leyeco II has received the same day which to date have not been favored by a reply, unfortunately expressing my concern on the continued collection of the P5 flat rate metering charge and the increase to P0.3460 from P0.0777 per kWh of the metering charge. For my personal appreciation, may I be informed what this P5 flat rate metering charge is for? And the metering charge on a per kWh basis which went up to P0.3460/ kWh as a result of the provisional increase granted under ERC case no. 2009-111RC from the previous P0.0777?

Further may we know the reason for such increase in the metering charge?

Moreover may I also be informed what the supply and the distribution charges are for?

In the spirit of transparency and accountability I look forward to your immediate and favorable reply. Should you continue to ignore my letter, I will be constrained to seek judicial relief.
